AGENDA ITEM NO. 1: TO CONSIDER CONSTRUCTION OF ACADEMIC AND ADMINISTRATIVE BLOCKS OF THE UNIVERSITY

The Registrar presented the requirement prescribed by the University grants Commission (UGC) for offering Open and Distance Learning (ODL) Programmes. As per the requirement there is need to a minimum of 15000 sq ft of the carpet area for the academic and administrative functioning of an Open University.

The Academic Council has requested the Registrar to initiate the process of construction of the University, as per the provisions made in the MTSOU Act 2024 keeping in view of the requirements laid down in the University Grants Commission (Open and Distance learning and Online Programmes) Regulations, 2020.

AGENDA ITEM NO. 2: TO CONSIDER ESTABLISHMENT OF SCHOOLS OF STUDIES

As per the provisions made in the MTSOU Act 2024, the Registrar proposed for the establishment the following six schools of Studies initially.

- 1. School of Management Studies and Commerce
- 2. School of Humanities and Social Sciences
- 3. School of Computer Science and Information Technology
- 4. School of Vocational Education and Training
- 5. School of Tourism and Hospitality Service Management
- 6. School of Health Sciences

The Board of Management after thorough discussion has considered and approved establishment of six schools of Studies as proposed, and recommended that more Schools of Studies may be established in future as per requirement of the University.

Agenda No 4: TO CONSIDER AND APPROVE THE IMPORTANT NORMS FOR ODL PROGRAMMES

The Dean, Academic presented the following:

- 1. Nomenclature of the ODL Programmes to be offered would be as per UGC Notification on Specification of Degrees, 2014 and its Amendments issued from time to time by the UGC.
- 2. Entry level qualification for all the ODL Programmes to be offered would be as per the UGC guidelines.
- 3. Evaluation methodology in 30:70 ratio for continuous assessment and term end examination
- 4. Curriculum of the would be Programmes would be in accordance with the University Grant Commission (Open and Distance Learning Programmes and Online Programme) Regulation, 2020, following the National Education Policy, 2020.
- 5. Pattern of the question papers for end semester examination as per requirement of the Programme.

Minimum passing marks shall be 40%.

After detailed discussion, the Academic Council considered and approved the ODL Norms proposed above.
